Trump Federalizes D.C. in Unprecedented Move Invokes Section 740, Deploys National Guard

On August 11th, President Trump announced the federalization of D.C.'s Metropolitan Police Department (MPD) by invoking Section 740 of the District of Columbia Home Rule Act of 1973.

Citing a "crime emergency" in the nation's capital, Trump also ordered the deployment of approximately 800 National Guard troops to patrol the city, declaring it "Liberation Day" for D.C.

The executive order, signed alongside a presidential memorandum, places the MPD under the direct control of Attorney General Pam Bondi, with Drug Enforcement Administration chief Terry Cole appointed as interim federal commissioner.

Speaking at a White House press conference, Trump described D.C. as plagued by "violent gangs, bloodthirsty criminals, roving mobs of wild youth, drugged-out maniacs, and homeless people." He claimed the federal takeover was necessary to "take our capital back." Trump pointed to high-profile incidents, including the murder of a 21-year-old congressional intern in June and an attempted carjacking of a former Department of Government Efficiency (DOGE) staffer, as justification for his actions.

Section 740 of the Home Rule Act allows the president to assume control of the MPD for federal purposes during "special conditions of an emergency nature." The takeover is initially limited to 48 hours but can extend to 30 days with congressional notification, which Trump has reportedly provided. Legal analysts warn that permanent control would require congressional repeal of the Home Rule Act, a move likely to face significant Democrat resistance.

D.C. Mayor Muriel Bowser, a Democrat, sharply criticized the move, calling



it "unprecedented" and claiming that violent crime in D.C. has dropped to a 30-year low, stating, "Washington, D.C. is a beautiful city... We are at a 30-year low in violent crime."

Local residents and leaders expressed mixed reactions. A "Free DC" rally near the White House saw activists decry the takeover as an assault on D.C.'s autonomy. "This is not about crime," one activist said. "This is about silencing dissent." Conversely, some residents, like Leroy Thorpe of the Citizen Organized Patrol Efforts, supported the move, citing persistent safety concerns. "I think it's needed," Thorpe said. "Something has to be done."

D.C.'s non-voting delegate, Eleanor Holmes Norton, called the action "an egregious assault on D.C. home rule," arguing that it undermines the self-governance of the city's 700,000 residents. Norton and Senator Chris Van Hollen plan to reintroduce legislation in September to grant D.C. full control over its police and National Guard. The D.C. Council labeled the takeover a "manufactured intrusion," while the city's police union cautiously supported it, calling for temporary intervention to ad-

dress staffing and legislative issues.

Critics, including Senate Minority Leader Chuck Schumer and Senator Chris Murphy, accused Trump of using the takeover as a distraction from controversies, such as his administration's handling of Jeffrey Epstein-related documents. Republicans, however, praised the move, with House Speaker Mike Johnson stating, "Every American should be able to visit and enjoy Washington, D.C. without fear."

The deployment of National Guard troops and additional federal law enforcement, including FBI agents and U.S. Park Police, raises concerns about potential overreach. The American Civil Liberties Union warned that Trump's actions could foreshadow similar interventions in other cities. Legal challenges are anticipated, with D.C. Attorney General Brian Schwalb calling the move "unlawful."

As D.C. deals with increased federal presence, the debate over crime, governance, and executive power intensifies. Trump's actions signal a broader law-and-order agenda, but with local opposition mounting, the future of D.C.'s autonomy hangs in the balance.

"Russiagate" Hoax Disclosure Will There Be Indictments?

The recent declassification of documents has blown the lid off the so-called Russiagate hoax, confirming long-held suspicions that the narrative of Trump-Russia collusion in the 2016 election was a fabricated plot orchestrated by powerful elites to undermine a duly elected president. These revelations, spearheaded by Director of National Intelligence Tulsi Gabbard, expose a coordinated effort by Obama-era officials, intelligence agencies, and complicit media to push a false narrative, vindicating those who've been shouting about a "deep state" coup for years. The documents, coupled with whistleblower accounts, reveal a scandal of unprecedented scale, implicating high-profile figures and shaking the foundations of trust in U.S. institutions.

On July 18th, Gabbard released the first batch of declassified documents, followed by more on July 30th, showing that in December 2016, the intelligence community (IC) initially concluded Russia did not interfere in the 2016 election via cyber attacks. "For months preceding the 2016 election, the Intelligence Community shared a consensus view: Russia lacked the intent and capability to hack U.S. elections," Gabbard recently posted to the social media platform X "But weeks after President Trump's historic 2016 victory defeating Hillary Clinton, everything changed." A Presidential Daily Brief drafted on December 8, 2016, stated Russian actions didn't impact vote counts, but this was scrapped after a December 9 White House meeting led by President Barack Obama. Attendees, including CIA Director John Brennan, DNI James Clapper, FBI Deputy Director Andrew McCabe, National Security Advisor Susan Rice, Secretary of State John Kerry, and Attorney General Loretta Lynch, pivoted to craft a politicized January 2017 Intelligence Community Assessment (ICA). This ICA falsely claimed Russia intervened to help Trump, relying on the discredited, Clinton-funded Steele Dossier, a dossier Clapper and others privately dismissed but publicly propped up.

A whistleblower's account, released on July 30, details six years of suppressed efforts to expose this manipulation. The senior IC official faced pressure from their supervisor to endorse the ICA's false findings for a promotion, refused to comply, and reported concerns to over a dozen government offices, including the IC Inspector General, only to be ignored or threatened. The whistleblower highlighted the ICA's reliance on cherry-picked Russian media as "evidence" while ignoring contradictory reports from NATO allies. Gabbard's whistleblower protections enabled this truth to surface, revealing how Obama's team weaponized intelligence to de-legitimize Trump's presidency.

The Durham Annex, discovered by FBI Director Kash Patel in a "burn bag" and declassified on July 31st, further implicates Hillary Clinton. It shows she personally approved the Trump-Russia hoax, using the FBI to amplify the narrative, with funding funneled through her campaign's lawyer Marc Elias at Perkins Coie, disguised as "legal services." Clinton's campaign faced a mere \$113,000 fine in 2022 for this deception, a slap on the wrist for what's now called a "years-long coup."

It was a team effort. Barack Obama allegedly directed the ICA's rewrite to sabotage Trump. Hillary Clinton approved the false narrative, with her campaign funding the Steele Dossier. John Brennan, James Clapper, Andrew McCabe: Crafted and pushed the ICA, leaking to media like Ellen Nakashima at the Washington Post, who planted stories on the DNC "hack," ICA "consensus," and Carter Page's FISA warrants. Susan Rice, John Kerry, Loretta Lynch: Participated in the pivotal White House meeting. Brian Netter: DOJ official who approved a \$2 million payout to FBI agents Peter Strzok and Lisa Page, implicated in the hoax, now tied to Elias's Democracy Forward.

The corporate media's complicity is glaring. Outlets like CNN, MSNBC, and the New York Times, which won Pulitzers for Russiagate coverage, have downplayed or ignored these revelations, protecting their role in spreading the hoax. Brennan, now an MSNBC analyst, and Clapper, a CNN contributor, deflect criticism while their networks bury the story.

For so called "conspiracy theorists", this is sweet vindication. The "deep state" narrative, once mocked, is now backed by hard evidence. The DOJ's July 23rd strike force to investigate these disclosures signals potential accountability, with calls for indictments growing louder. The truth, long buried, is finally out, proving the skeptics right.

Make America Beautiful Again

New Commission Tackles Federal Lands



On July 3rd, President Donald J. Trump signed Executive Order 14313, establishing the Make America Beautiful Again (MABA) Commission, an initiative to conserve America's natural treasures while expanding access to public lands, with significant implications for Arizona's environment, tourism, and economy.

Chaired by Secretary of the Interior Doug Burgum, the commission aims to address decades of mismanagement, cut bureaucratic red tape, and promote outdoor recreation, directly benefiting Arizona's iconic landscapes like the Grand Canyon, Saguaro National Park, and vast public lands. For a state where tourism generates \$29 billion annually and supports 270,000 jobs, according to the Arizona Office of Tourism, MABA's focus on enhancing national parks and recreational access promises to amplify Arizona's economic and cultural vitality while safeguarding its natural heritage.

Arizona, with 6.3 million acres of national forests and 12 national parks, stands to gain from MABA's mission to tackle the \$23 billion National Park Service maintenance backlog and \$10.8 billion in U.S. Forest Service repairs. The commission's emphasis on active forest management and voluntary conservation, as outlined in the executive order, could potentially restore areas like the Coconino National Forest, ravaged by recent wildfires, ensuring safer trails and healthier ecosystems for Arizona's hikers, hunters, and anglers.

By expanding access to public lands for activities like off-roading and wildlife viewing, MABA aligns with Arizona's outdoor recreation economy, which contributes \$10.7 billion annually, per a 2024 Bureau of Economic Analysis report. This could drive tourism to rural areas, boosting local businesses and job creation.

The commission's push to recover fish and wildlife populations through collaborative efforts with state agencies, such as the Arizona Game and Fish Department, directly benefits Arizona's biodiversity. The state's endangered species, like the Mexican gray wolf, could see strengthened recovery programs.

MABA's focus on clean water access also addresses Arizona's pressing water challenges, potentially improving aquatic ecosystems in the Colorado River Basin.

The commission's 11-member panel, including the Secretaries of Defense, Agriculture, and the EPA Administrator, will ensure a colaborative and coordinated approach, leveraging Arizona's input through its robust federal delegation.

The MABA initiative responds to Arizona's concerns over a proposed 1.2 million-acre public land sale, which Senator Mike Lee withdrew after backlash, ensuring lands like those near Lake Mead remain protected for public enjoyment. This pivot, celebrated by Arizona's conservationists, aligns with the state's legacy of stewardship, exemplified by Theodore Roosevelt's establishment of the Grand Canyon as a national monument. MABA's potential to increase park entrance fees and attract international tourists, as noted in a July 10th, Headline USA report, could funnel revenue to Arizona's underfunded parks, enhancing infrastructure like trails and visitor centers.

While the Rescissions Act of 2025 cut \$9 billion in federal funding, MABA's focus on cost-effective conservation ensures Arizona's natural assets remain a priority.

Championed by young conservative activist Benji Backer, who drafted the order, MABA reflects Arizona's values of balancing economic growth with environmental stewardship, promising a brighter, more accessible natural legacy for future generations.

Trump's Trade Deals

Agreements, Deadlines, and Economic Risks

President Trump's tariff strategy has produced trade agreements with Japan, South Korea, the European Union, Indonesia, the Philippines, Pakistan, and a imposed a punitive tariff on India. While these deals are framed as economic victories, they carry risks for American consumers and global trade.

On July 22nd, Trump finalized a deal reducing tariffs on Japanese goods from 25% to 15%, effective August 7th. Japan committed to \$550 billion in U.S. investments in semiconductors, pharmaceuticals, steel, and energy, and opened markets for U.S. autos and agricultural products, including a 100,000-ton increase in duty-free rice quotas. A US-Japan LNG venture in Alaska was also announced. However, the \$550 billion investment lacks a clear timeline, raising doubts about enforceability. Japanese automakers like Toyota benefit, but US consumers face higher prices due to the 15% tariff. Japan's automotive exports, 20% of its U.S. trade, face additional 25% sector-specific tariffs, potentially disrupting supply chains for U.S. automakers reliant on Japanese parts.

The July 22nd Indonesia deal reduces tariffs from 32% to 19%, with Indonesia eliminating 99% of tariffs on US goods, adopting US standards, and committing to \$15 billion in energy, \$4.5 billion in agriculture, and 50 Boeing jets. However, the 19% tariff could still price Indonesian textiles and agricultural exports out of the US market, critical for its economy. Adopting US standards may burden Indonesian producers with compliance costs, and the deal's ban on forced labor and illegal logging, while ethical, could disrupt supply chains, raising prices for US consumers of Indonesian goods.

Announced July 22nd, the Philippines deal sets a 19% tariff, down from 20%, with US goods gaining zero-tariff access. It aims to address the \$4.9 billion US trade deficit but risks higher US consumer prices for Philippine exports like electronics.

The EU deal, signed July 27th, sets a 15% tariff on 70% of goods, down from 30%, with the EU committing to \$750 billion in US energy purchases, \$600 billion in investments, and \$40 billion in AI chips by 2028. It includes zero-for-zero tariffs on strategic goods and eliminates industrial tariffs. However, the 50% tariff on EU steel and aluminum persists, raising costs for US manufacturers. The deal's non-binding nature and need for approval by 27 EU states create uncertainty, and the EU's \$236 billion trade surplus may prompt retaliatory tariffs, threatening US exports.

Announced July 31st, the South Korea deal lowers tariffs from 25% to 15%, with South Korea pledging \$350 billion in investments in shipbuilding, semiconductors, and biotech, plus \$100 billion in US purchases of LNG. US goods gain zero-tariff access, and South Korea avoids harsher semiconductor tariffs. Yet the 15% tariff could raise costs for US consumers, with a \$1,000 ton of POSCO steel now costing \$1,500.

The Pakistan deal, vaguely tied to oil reserve development, lacks clear tariff rates or commitments. The 19% tariff could disrupt Pakistan's textile exports, a key economic driver, while the deal's opacity raises doubts about enforceability. Geopolitical motivations, including Pakistan's ties to China, may complicate US relations, with little economic gain for either side.

August 6th, Trump imposed a 25% tariff on India, escalating to 50% in 21 days due to its Russian oil and weapons trade, effective August 27th. India offered zero tariffs on US industrial goods and \$25 billion in energy purchases, but talks stalled over agriculture and dairy. The 50% tariff could halt India's \$40 billion in exports like textiles and pharmaceuticals. Negotiations have broken down and the tariff strains US-India strategic ties, potentially pushing India closer to Russia or China.

Since July, deadlines have shifted. August 1st became August 7th bcame expired without mention, Mexico's talks extended to October 30th, and China's truce to November 11th. These extensions reflect ongoing trade negotiations and strategic pauses to avoid immediate economic disruptions, despite Trump's earlier insistence on "no extensions" for the August 1st deadline.

Tariff revenue hit \$150B since October 2024, but US consumers face an estimated \$3K per household in added costs. Thusfar, these agreements, far from Trump's 90-deals in 90 days goal, may benefit the federal government's bottom line but have hit consumers in the wallet.

Trump Orders New Census Illegal Aliens Won't Count

President Trump's recent directive to the Department of Commerce to initiate a new US census, announced on August 7th, marks a decisive step toward ensuring fair representation for American citizens. This move addresses long-standing concerns about the inclusion of illegal aliens in the decennial census, which many argue distorts congressional apportionment and electoral power. By ordering a census that excludes non-citizens and leverages data from the 2024 presidential election, Trump aims to restore integrity to the process, prioritizing the voices of legal residents and bolstering GOP prospects in the 2026 midterms.

The Constitution mandates a census every decade to allocate House seats and federal funding based on the "whole number of persons" in each state. However, Republicans, including Trump, contend that counting illegal aliens inflates representation in states like California, which lean Democratic, at the expense of red states like Texas and Florida. These states, experiencing rapid population growth, were undercounted in the 2020 census, according to a 2022 Census Bureau report, potentially costing them additional House seats. Trump's directive seeks to correct this, ensuring that only citizens shape congressional apportionment. Supporters argue this aligns with fairness, as non-citizens should not influence political power.

This initiative resonates with GOP lawmakers pushing for mid-decade redistricting. Republicans view this as a necessary counter to what they see as Democratic exploitation of census data to maintain urban strongholds. They also highlight logistical feasibility, noting that the Census Bureau's American Community Survey could be adapted for a mid-decade count, bypassing the massive undertaking of a full census. Critics argue that excluding non-citizens violates the 14th Amendment and could face legal challenges, as seen when the Supreme Court blocked Trump's 2019 attempt to add a citizenship question to the 2020 census.

While legal and logistical hurdles loom, the GOP sees this as a patriotic stand to ensure representation reflects the will of American voters, not undocumented residents. As redistricting battles heat up, Trump's census push could reshape the political landscape, strengthening Republican influence for years to come.

Local Government Investment Pool Record Growth A Financial Boon for County

The Arizona State Treasurer's Office announced a historic milestone: the Local Government Investment Pool (LGIP) has soared to a record \$7.6 billion in total assets, a 131% increase since Treasurer Kimberly Yee took office in 2019. This growth, driven by strategic management and favorable market conditions, is delivering tangible benefits to local governments across Arizona.

The LGIP allows counties, cities, towns, special districts, community colleges, and tribal governments, to pool their funds for investment. Managed by the Treasurer's Office, the LGIP offers economies of scale, professional oversight, and lower costs than private investment options. With four pools tailored to varying liquidity needs, the program prioritizes safety, liquidity, and competitive yields. In July 2025, the LGIP earned \$24.49 million, with June earnings at \$27.4 million, a 3.18% year-over-year increase. Pool 5, a diversified short-term fund, has maintained top "AAAf" and "S1+" ratings for 17 years, reflecting its stability.

Mohave County, one of 11 participating counties, reaps direct benefits from this record-high fund balance. These earnings, flow back to participants, enhancing Mohave County's general fund. The LGIP's growth also mitigates economic risks tied to national policies, such as President Trump's tariffs. While tariffs have driven up costs for goods, increasing consumer prices by an estimated \$3,000 per household, Mohave County's LGIP participation provides a financial cushion.

The LGIP's success depends on market conditions, and a downturn could reduce yields. For now, Mohave County benefits significantly from the LGIP's record \$7.6 billion balance. As Treasurer Yee noted, "We are proud to provide responsible stewardship of public funds while ensuring liquidity, safety, and strong returns." For Mohave County, this stewardship means a stronger financial foundation to navigate economic uncertainties and invest in its future.

Recission Bill Cuts Media FundingUSAID, Public Broadcasting Cuts

Following closely on the heels of the "One Big Beautiful Bill (H,R. 1), the Rescissions Act of 2025 (H.R. 4), signed into law by President Trump on July 24th, deals a serious blow to the entrenched "deep state" and wasteful government spending, clawing back roughly \$8 billion in previously approved federal funds.

The bill, which passed the House (216-213) in a late night vote on July 18th and the Senate (51-48) on July 17th, targets \$7.9 billion in foreign aid and \$1.1 billion for the Corporation for Public Broadcasting (CPB), which funds propaganda outlets NPR and PBS, outlets long accused of liberal bias. This move, the first successful presidential rescission since 1999, codifies cuts proposed by the Department of Government Efficiency (DOGE), exposing the bloated bureaucracy critics have railed against for years.

Key Republican figures such as House Speaker Mike Johnson and Senate Majority Leader John Thune championed the bill, while House Representatives Brian Fitzpatric and Mike Turner along with Senators Susan Collins and Lisa Murkowski joined Democrats in opposition, citing risks to rural emergency alerts and global health programs like PEPFAR, which saw a \$400 million cut removed after GOP moderates pushed back. Critics, Senate Minority Leader Chuck Schumer and Democratic Leader Hakeem Jeffries, warned the bill undermines Congress's spending authority and America's global influence.

Specific cuts include \$800 million from refugee assistance, \$496 million from disaster aid, and \$4.15 billion from economic and democratic development programs, aligning with DOGE's mission to slash "unnecessary" spending.

Conservatives see this as proof of a long-hidden agenda to redirect taxpayer money to globalist causes, with Trump's team, including OMB Director Russ Vought, signaling more rescissions to come. Repblicans are also planning a second reconcilliation bill, in the wake of the passage of the :Big Beautiful Bill".

However, the bill's passage, enabled by the Impoundment Control Act of 1974, has sparked fears of eroded legislative checks, with Democrats vowing tougher resistance to future cuts and vowing a government shutdown in the fall.

For those who've long suspected government overreach, this is a rare victory, though the fight against the uniparty fiscal bloat continues.

Davis Rose, a Lake Havasu City pastor and Lake Havasu Unified School District School Board President, is also running for a Seat in the House. Rose has stated that if elected he will not step down from the LHUSD School Board.

Grounded in "faith, family, and the Constitution", Caroline is running to secure Arizona's border, eliminate wasteful spending, defend 2nd Amendment rights, protect parental authority in education, and ensure local control of water and land. She believes rural Arizona needs leaders who live and work in the communities they represent, not career politicians who just switch seats or big-city elites.

Make Arizona Healthy Again!

Since taking office as U.S. Health and Human Services (HHS) Secretary on February 13th, Robert F. Kennedy Jr. has driven transformative changes under his "Make America Healthy Again" initiative, aiming to address the nation's chronic disease epidemic and restore public trust in health policy.

On June 23rd, Kennedy secured a landmark agreement with major health insurers to implement six reforms, streamlining care delivery and enhancing transparency for nearly 260 million Americans. These changes reduce bureaucratic hurdles, empower patients with clearer information, and prioritize timely access to care, aligning with MAHA's goal of making healthcare more patient-centered and efficient. Kennedy's bold restructuring, slashing 10,000 jobs and consolidating HHS from 28 to 15 divisions by July 14th, saved \$1.8 billion annually. This overhaul, aligned with the Department of Government Efficiency (DOGE), refocused HHS on chronic disease prevention, cutting bureaucratic bloat to prioritize MAHA's mission of life changing outcomes. Supporters argue this streamlined structure enhances accountability and redirects resources to critical areas like nutrition and preventive care.

Earlier this month, Kennedy canceled approximately \$500 million in funding for 22 mRNA vaccine development projects managed by the Biomedical Advanced Research and Development Authority (BARDA), targeting respiratory viruses like COVID-19, flu, and H5N1 bird flu. Kennedy justified the move by stating that mRNA vaccines are ineffective against upper respiratory infections and pose more risks than benefits, citing a "comprehensive review" of scientific data. According to Kennedy mRNA injections "only code for a small part of the viral protein, usually a single antigen." And "One mutation and the vaccine becomes ineffective" he said. "This dynamic drives a phenomenon called antigenic shift, meaning that the vaccine paradoxically encourages new mutations and can actually prolong pandemics as the virus constantly mutates to escape the protective effects of the vaccine." This decision, which followed the earlier cancellation of a \$766 million Moderna contract for bird flu vaccine development, has been praised by Children's Health Defense and others, as a step toward protecting public health.

In June, Kennedy reformed the Advisory Committee on Immunization Practices (ACIP), replacing members to ensure diverse perspectives and canceling public meetings to focus on rigorous internal reviews. His push for full clinical trial data release, including vaccine safety stud-

ies, aims to rebuild public trust.
Kennedy's pledge to uncover autism's causes by September 2025, backed by the MAHA Commission, dedicates significant resources to studying chronic childhood conditions, addressing con-

cerns long ignored by traditional health agencies.

His insurance reforms, food safety initiatives, and HHS restructuring are a step towards fulfilling MAHA's promise to prioritize prevention over sick care, tackling root causes of chronic disease. His vaccine transparency efforts empower parents with informed consent.



The DOGE Report

The Last 30 Days at the Department of Government Efficiency

Over the past month, the Department of Government Efficiency (DOGE) has continued stirring controversy, legal battles, and headlines, under Acting Administrator Amy Gleason. Here's a look at the latest in this high-profile efficiency initiative that reads more like political theater than a typical government agency.

1. Legal Victory: Access to Sensitive Data Granted

A U.S. appeals court recently ruled in favor of the Trump administration's DOGE, overturning a lower court's injunction that had barred DOGE from accessing sensitive federal data. The ruling now permits DOGE to retrieve information from agencies including Education, Treasury, and the Office of Personnel Management—even data like Social Security numbers and citizenship records—despite ongoing privacy and legal concerns.

2. Al-Driven Regulatory Cuts Spark Ethical Debate

Insiders report that DOGE—once helmed by Musk—is now using artificial intelligence to identify regulations for removal. The so-called "Doge AI Deregulation Decision Tool" is analyzing around 200,000 rules to recommend slashing up to 50% of them by the end of DOGE's first year. The accelerating pace of deregulation has triggered legal and ethical discussions around automating policy decisions.

3. Violence Against 'Big Balls'—A Hero Under Fire

In Washington, D.C., former DOGE software engineer Edward Coristine—nick-named "Big Balls"—was severely injured while defending a companion from a juvenile carjacking. The incident drew national attention, with praise from both Musk and Trump for Coristine's bravery. The accused teens have been ordered to remain in juvenile custody amid rising concerns about urban crime and public safety. Coristine now works for the Social Security Administration.

4. Policy Repeals and Internal Reversals

One of Musk's initiatives at DOGE required federal workers to send weekly "5 things" emails detailing their accomplishments—often compared to corporate task metrics. The program, widely derided for being overly controlling, has now been officially terminated by the Office of Personnel Management.

A Snapshot of DOGE's Year So Far Origins & Purpose

DOGE was established in January 2025 by executive order, transforming the U.S. Digital Service into the U.S. DOGE Service. Its mission: modernize federal IT, slash spending and regulations, and boost efficiency. The initiative is set to dissolve by July 4, 2026.

Elon Musk's Role

Musk served as a "Special Government Employee" and senior adviser. Though Trump often portrayed him as leading DOGE, legal filings clarify that Musk held no formal authority to make decisions. He officially stepped back from the role in May, citing frustrations with bureaucratic hurdles, though he remains informally supportive.

Claims vs. Reality

DOGE initially claimed up to \$160 billion in savings within its first 100 days, with goals set as high as \$1 trillion. Independent audits—by Politifact, the Wall Street Journal, and others—identified inflated accounting, double-counted contracts, and contested savings. The actual verifiable value of cuts remains significantly lower.

Public Backlash & Lawsuits

The initiative has faced sustained legal and public opposition. Allegations range from unconstitutional overreach, privacy violations, to improperly laid off federal workers. Courts have begun blocking some of DOGE's more aggressive actions.

What This Means Going Forward

Dogecoin meme, real impact: What started as a symbolic "meme-inspired" efficiency crusade has driven major policy changes—and national scrutiny.

Al-powered governance raises alarm: Automating regulation cuts via Al may offer speed, but not without ethical and legal fallout.

Legacy uncertain: With Musk stepping down and public trust faltering, DOGE's lasting influence will likely be more cautionary than celebratory.

Hate Speech is not Speech Extremists Hate

When even one American, who has done nothing wrong, is forced by fear to shut his mind and close his mouth, then ALL Americans are in peril. - President Harry Truman

Executive Order 13899 went largely unnoticed in Trump's first term. It adopted the International Holocaust Rememberance Alliance definition of anti-Semitism, which sounds harmless enough until you read it and see how it's applied.

Then on January 29th of this year Trump issued Executive Order 14188, the "Additional Measures to Combat Anti-Semitism", which built on the previous EO and emphasized investigating individuals and institutions critical of the government of Israel.

Imagine the US government weaponized against Americans critical of any other foreign government. Replace the word Israel with any other nation, in any context, and see if it passes the smell test.

But wait, we are constantly being told, ad nauseum, that Israel is our greatest ally. Well, if Israel is really our greatest ally then why have they never sent any troops to help us fight a war? Asking questions like that might get you branded an "anti-Semite".

Mention the 1965 NUMEC scandal, where 200-300 kg of US enriched uranium vanished from a Pennsylvania plant and declassified CIA/FBI docs suggest Israeli agents diverted it for Israel's nuclear program and you might be an "anti-Semite"

Bring up June 8, 1967, when Israeli forces intentionally attacked the Navy ship USS Liberty in international waters, killing 34 and wounding 17 Americans and you might be an "anti-Semite".

Share an old video about Rachel Corrie, a 23-year-old American, who was killed in 2003 in Gaza when an Israeli bulldozer ran her over on purpose during a peaceful protest against home demolitions and you might be an "anti-Semite".

Write a social media post about how in 1993, CIA Director James Woolsey testified that Israel sold U.S. military tech like missiles and jets to China for over a decade, worth billions, or that in 2013 Israel transferred U.S. missile electro-optics to China, or that in 2021 ten Israelis were indicted for illegally exporting American cruise missiles to China, and... "anti-Semite".

Talk about the fact that Edward Snowden documents showed Israel spies on and collects data from America more than any other country and... "anti-Semite".

Try to explain that anti-Zionism is not anti-Semitism, or that not all Jews are Zionists and not all Zionists are Jews, oppose bombing and starving women and children in Gaza, question America sending \$3.8 billion in aide annually to Israel when Americans are suffering, or point out that Israeli Prime Minister Benjamin Netanyahu is really Polish and his family changed their name from Mileikowski, and you can expect to be labeled an "anti-Semite". Katie Hobbs' Clown Car of Incompetence: Why Isn't She in Jail?

It's a question everyday Arizonans are asking more and more often: How is Governor Katie Hobbs still in office, let alone not under indictment?

From Medicaid fraud to pay-to-play politics, from water giveaways to foreign adversaries to election cybersecurity disasters, Hobbs has delivered a masterclass in mismanagement, incompetence, and corruption. And yet, somehow, she and her running mate Attorney General Kris Mayes...both up for re-election, act like the law doesn't apply to them.

Let's cut the nonsense. If a Republican had a fraction of this record, they'd already be in handcuffs.

The Hobbs administration reads like a rotating door of failed leadership and scandal. Her Chief of Staff Allie Bones resigned early amid dysfunction. Press Secretary Josselyn Berry stepped down after posting violent rhetoric on social media. Tourism Director Lisa Urias resigned over a self-dealing contract. AHCCCS Director Carmen Heredia and Health Services Director Jennie Cunico both fled under pressure from fraud investigations. Dana Allmond, appointed to lead Veterans Services, was reassigned with a six-figure salary after failing Senate confirmation.

That's at least six confirmed cabinetlevel or senior staff resignations. In less than two years.

Under Hobbs' watch, the Arizona Health Care Cost Containment System (AHCCCS) fell into total disrepair, allowing \$2.5 billion in Medicaid fraud to flourish, exploiting vulnerable Native Americans while her hand-picked directors looked the other way.

And what was the response? Political reshuffling, golden parachute salaries, and staged reassignments. No accountability. No prosecutions. Just "move along, nothing to see here."

What happens when you donate \$400,000 to Democrat-affiliated PACs and Hobbs-aligned organizations? Apparently, you get a 60 percent rate



County Board Report

A Kingman man's appeal of an "unsafe structure" could lead to changes in the County's Building Code. After hearing from Chief Building Official, Gilbert Smaby, District 5 Supervisor Ron Gould asked the Board to change the permitting process for roofing and re-roofing projects. Gould moved to amend the MC Building Safety Code to exempt re-roof permits if the related repairs are 10% or less or up to 128 square feet of the roof's surface when using the same shingles or tiles to complete the repairs. A public hearing is set for the August 18th meeting.

Deputy County Attorney, William Davis, set a public hearing for the August 18th meeting to discuss a proposed ordinance regulating the residency of certain registered sex offenders. The change would prohibit Level 2 and Level 3 Sex Offenders from residing closer than 1,000 feet of schools, daycares and near places where children commonly gather. Bullhead City resident, "Scotty" McClure has been vocal about the number of out-of-state offenders who move into the County.

Supervisor Gould once again asked Economic Development Director Tami Ursenbach to change her scope of outreach, eliminating data centers due to their high water and energy usage. Mohave Electric Cooperative CEO Tyler Carlson-reached out to Gould explaining that their company could not handle the energy load required for a data center. After research, Gould determined the rural areas of the County couldn't handle the necessary water and energy requirements and requested the change. Supervisors Sonny Borrelli and Don Martin dissented.

The Mohave County Airport Authority (MCAA) continues to be a thorn in District 2 Supervisor Rich Lettman's side with District 3 Supervisor Sonny Borrelli jumping into the fray. The MCAA has been uncooperative when asked for their financial information, something that should be available to the public as well as the County upon request. Due to their snubbing, Borrelli has asked for assistance from the Arizona Joint Legislative Audit Committee.

After a presentation from the American Lands Council, showing a majority of public lands in Arizona are federally owned, the Board voted to join the American Lands Council for a \$5k/yr Silver Membership to support their efforts in returning those lands to state control.

The County is approaching property tax time and the Board was asked to approve the adoption of Fiscal Year 2025-2026 tax levies and rates for Mohave County tax authorities and acknowledge tax levies submitted from special districts, school districts, fire districts, cities and towns. Supervisor Gould requested the Board approve the submitted tax levies minus Mohave Valley Elementary School District and the Topock School District, due to citizen complaints regarding their Truth in Taxation hearings. While the districts did place notice in a newspaper of record, they didn't allow citizens to speak directly to the item and did not separately agendize the item from the rest of their regular board meeting. Many Topock residents spoke against a nearly 300% increase in their school district's levy, stating that it would cause severe hardship to many of their residents. The Board ultimately agreed with Gould, except for District 4 Supervisor Don Martin.

Board Clerk Laura Skubal will be sticking around for another year. Supervisors voted to accept Ms. Skubal's annual review and a step increase in pay. The Board also voted to extend County Manager Sam Elter's contract which was set to expire in November, but due to Mr. Elter's stated intent to retire, the Board felt it necessary to keep him on until 2026 to allow for time to find a replacement.

Golden Valley Matters

As we predicted in the last issue, the anticipated update to the Mohave County General Plan (GP), that includes a huge Angle Homes planned community in the northwest part of the Valley, has been stalled due to acknowledged Open Meeting Law (OML) violations.

With only days to read it instead of the "at least sixty days" required by A.R.S 11-805 section F, the Supervisors were expected to rubber stamp the 170-plus page document, despite no presentation even being made to them to explain the changes by the Development Services Department.

But with separate Open Meeting Law complaints made to the AZ Ombudsman and the County Attorney's office, the Board was forced to send the Draft Plan back to the Planning and Zoning (P&Z) Commission. While the Ombudsman's Open Meeting Law Enforcement Team (OMLET) has yet to issue a report on it's findings, Civil Deputy County Attorney Jason Mitchell confirmed that their office had substantiated at least the one allegation that "an Open Meeting Law Violation had occurred for each meeting where an agenda was not posted."

The Board's vote to reject the plan was unanimous, and the law (A.R.S. 11-805, section L) will require any future version of the GP to be approved by a 2/3 majority (unanimous on a 5 member board) vote. If they fail to adopt or re-adopt a version of the plan, then the current plan remains in effect until a new one passes. They must consider a new plan or reconsider the proposed plan within one year, and must continue to do so until a plan is adopted. There is no hard deadline for the Supervisors to approve a new 10 year growth plan, so it looks like concerned GV residents will have a new round of public comment battles with Angle Homes.

What will that process look like? Well according to Development Services Director Scott Holtry, at the July 13th P&Z meeting, they are going to "re-do all 8 Subcommittee presentations, but...abbreviate them a little bit" at one very long regular P&Z meeting next month, and "allow the public from any of those areas to come and voice any opinions, just to make sure that we're satisfying any and all public notices that we mentioned before." And "We will hold a special meeting with the Board of Supervisors and I believe they might have some changes that they're looking to make...we will have to come back another time to the Commission." Thus giving the general public another bite at the apple, or several, to drive home their concerns.

One additional issue that has recently been revealed upon research by the Mohave Free Press, is that the County was required by A.R.S 11-805, section B-1, to have, at some time in the past, formally adopted written procedures as to how the GP process would proceed. Yet nobody involved in the process appears to have been provided a copy of that document, so it in unknown if the law has even been followed in that regard. Was staff given a copy of the official procedures for drafting the GP and, if so, did they follow it to the letter? If all provisions of the law, A.R.S. 11-805, were not followed then is this nonfeasance on the part of County Manager Sam Elters or the County's legal counsel, or both?

Will OMLET impose the potential \$500 fine on lawbreaking members of the GP Subcommittee, or will everyone involved just get a slap on the wrist? Inquiring minds want to know. Coincidentally, a "training workshop" has been scheduled for August 26th at 3pm in the Board of Supervisor's Auditorium featuring "Guest Star" Will Davis, an attorney for the County.







Rumor Mill

RUMOR: Is Kingman running out of water or not?

TRUTH: Well, that depends on who you ask and what data they are citing, because any data modeling is dependent on the projected use numbers you input. Recently, conflicting reports started circulating when a heated dispute unfolded between LD30 State Representative John Gillette and Mohave County Board of Supervisors Chairman Travis Lingenfelter over the management of the Hualapai Basin's groundwater. The conflict centers on differing assessments of the aquifer's

water projections and the policies needed to ensure its sustainability.

The controversy began with Gillette's recent Final Assessment of the Hualapai Basin Water Data Integrity, which claimed the aquifer could supply the region for 100–300 years, even under heavy usage. Gillette argued that data from Mohave County and the City of Kingman overstated risks to justify restrictive policies. In the assessment, Gillette wrote, "After continued research, legislative engagement, and review of both historical and current data, my original 2021 assessment of the Hualapai Basin water situation remains valid. The data presented by the City of Kingman and Mohave County remains suspect, with indications of overstatement used to drive political narratives and policy agendas."

Gillette accused Lingenfelter of aligning with Democrat Governor Katie Hobbs and High Ground, LLC, a firm tied to the very liberal Walton Family Foundation and Environmental Defense Fund, to push policies that centralize water control under the state, potentially infringing on property rights and local control. In an email to AZ Free News, Rep. Gillette stated that Lingenfelter "has 'cozied up' with Governor Hobbs and High Ground, LLC., not by joining their party, but by aligning on a policy platform that places rural water in the hands of the Governor. He has advocated for several of the leftists' water bills that trample the rights of property owners." The County Board of Supervisors terminated their contract with lobbyist Nick Ponder of High Ground, LLC. earlier this year.

In a May 8th rebuttal letter, Lingenfelter struck back with, "Your letter unfortunately contains a series of flawed assumptions, technical inaccuracies, and mischaracterizations that misinform rather than advance the public dialogue around long-term rural groundwater sustainability in Mohave County." He added, "Your letter asserts that data presented by Mohave County and the City of Kingman remains 'suspect' and 'politically compromised.' Such a characterization is categorically false and impugns the reputations of Mohave County, City of Kingman, and credentialed hydrologists at the ADWR and USGS and the public they serve."

In a formal response to Lingenfelter's accusations, Gillette wrote on May 16th, "While I welcome constructive dialogue, your letter reflects a degree of emotional overreach rather than a calm, scientific response to the concerns raised. Unfortunately, it reveals more about political defensiveness than about data transparency or hydrological best practice." Rebutting criticism of his assessment's findings Gillette stated, "The assessment I authored was reviewed by three independent scientific and policy bodies prior to publication. All concluded that the findings were as accurate as possible given available data. I welcome peer review. What I reject is politically motivated resistance to scrutiny. As further evidence of bias, it should be noted that the 'comparison document' you reference—submitted by your team only days after my final assessment—contains several confirmations of my position."

Gillette also adressed Lingenfelter's claims based on the U.S. Geological Survey MODFLOW-NWT model and its 75,586 adjustable parameters "Your confidence in the model would carry more weight if you supported my proposal to recalibrate baseline figures using 15 new field test sites with controlled, non manipulated measurement inputs. This is the kind of ground-truth methodology science demands. Strangely, your rebuttal ignores this recommendation entirely."

Gillette backs Republican-led legislation like SB 1221, which would restrict water use in stressed basins like Hualapai while granting users water rights certificates. He argues this approach fairly distributes conservation burdens. In the 2026 legislative session Gillette intends to to pursue "a stand-alone Hualapai Basin bill-developed outside of executive influence-that reflects the data as it exists, not as it is manipulated."

Title 8 of the United States Code, Section 1325, addresses offenses related to improper entry by an alien into the country.



How to survive in a modern world

Harvesting rainwater is an ecofriendly way to conserve water, reduce utility bills, and support a sustainable lifestyle. A cistern, a storage tank for rainwater, is a practical addition to any homestead. You can build a 250-gallon above-ground cistern using readily available materials for about \$250-\$350. With basic tools and a weekend's effort, you can create a functional system to collect and store rainwater for gardening, cleaning, or emergency use.



Materials Needed:

250-gallon food-grade plastic drum or IBC tote

fine mesh screen, for debris filtering

concrete blocks, 8-12, for a stable base

PVC pipe - 2-inch diameter, 10 feet

PVC fittings - 2-inch ball valve, elbow joint, and bulkhead fitting

silicone sealant and waterproof tape

hacksaw, drill, measuring tape, level, and wrench

hose spigot and threaded adapter

gutter diverter kit (optional, for connecting to downspouts)

Select a flat, stable location near a downspout for easy rainwater collection. Ensure the area is accessible for maintenance and can support the weight of a full cistern (about 2,000 pounds). Clear debris and level the ground. Lay 8-12 concrete blocks in a rectangular pattern to create a sturdy base, checking with a level to ensure evenness. This prevents the cistern from tipping or cracking under weight.

Clean the food-grade drum or IBC tote thoroughly with a mild soap solution to remove any residue, especially if previously used. Rinse and let it dry. Inspect for leaks or cracks. Position the cistern on the concrete block base, ensuring the outlet (usually at the bottom) is accessible for installing a spigot. If the drum lacks a pre-installed outlet, drill a 2-inch hole near the bottom for the bulkhead fitting, following the fitting's instructions.

Insert the bulkhead fitting into the outlet hole, securing it with the provided gasket and nut. Apply silicone sealant around the fitting to ensure a watertight seal. Attach a 2-inch PVC ball valve to the bulkhead fitting, followed by a threaded adapter and hose spigot. Tighten all connections with a wrench and wrap threads with waterproof tape to prevent leaks. This setup allows controlled water release.

Cut a 2-inch hole near the top of the cistern for the inlet, where rainwater will enter. Attach a PVC elbow joint to direct water from your gutter system. Secure a fine mesh screen over the inlet to filter leaves and debris, preventing clogs and contamination. For overflow, drill another 2-inch hole just below the inlet and attach a PVC pipe to divert excess water away from the cistern's base, ideally to a garden or drainage area. Alternatively, you can build a "first flush diverter" to prefilter debris, ensuring that cleaner water is collected in the cistern.

If using a gutter diverter kit, install it on your downspout per the manufacturer's instructions. Connect a 2-inch PVC pipe from the diverter to the cistern's inlet, ensuring a slight downward slope for smooth water flow. Secure all connections with waterproof tape. Test the system for leaks by pouring water down the gutter.

Fill the cistern with a garden hose to check for leaks at the bulkhead, spigot, and inlet. Adjust fittings as needed. Regularly clean the mesh screen and inspect the cistern for algae or debris buildup. For potable use, add a filtration and purification system, as untreated rainwater may not be safe for drinking. An RV inline hose filter is a good idea to start with, if you think you might need to drink from it.

Place the cistern in a shaded area to reduce algae growth. Elevate the spigot at least 12 inches above ground for easy bucket access. In freezing areas, insulate the cistern or drain it during winter to prevent cracking. Always secure the lid to keep out pests and ensure child safety.
