

Trump Prepares for Peace, EU Prepares for War Can a Lasting Agreement Be Reached Between Russia and Ukraine?

Peace talks initially unraveled when Ukrain dictator Volodymyr Zelenskyy tried to publicly renegotiate a peace deal orchestrated by President Trump, while news cameras were rolling.

Zelenskyy disrespected Vice President JD Vance, by casually calling him "JD" and then under his breath called him "suka", the Ukrainian word for bitch. Zelenskyy was sent packing without the scheduled luncheon.

Trump's "Art of the Deal" negotiating skills were on full display with such memorable quotes as: "You don't have the cards.", "I've empowered you to act like a tough guy but once we're out you won't be so tough.", and "You'll either make a deal or we're out. And once we're out, you'll fight it out."

Zelenskyy then ran to the welcome arms of European Union leaders, and British Prime Minister Keir Starmer indicated readiness to send troops as part of a "coalition of the willing", stating on March 2nd that the U.K. would put "boots on the ground and planes in the air" but only with U.S. backing. French President Emmanuel Macron left the door open, notably on February 25th, affirming that European leaders are "ready to send troops to verify that peace is respected," contingent on American support, though he clarified on March 4th that no near-term deployment is planned. Leaders, such as Denmark's Mette Frederiksen and Poland's Donald Tusk, have shown openness to discussing troop deployments, with Tusk supporting a robust defense posture, while Germany's Olaf Scholz and Italy's Giorgia Meloni have expressed reluctance, citing overstretched resources and constitutional limits.

During a March 6th emergency EU summit in Brussels, European Council



President Antonio Costa declared, "Today we have shown that the European Union is rising to the challenge, building the Europe of defence and standing with Ukraine shoulder to shoulder," while proposing joint borrowing of up to 150 billion euros (\$160 billion) to fund military enhancements. This followed French President Emmanuel Macron's statement that "Europe faces a clear and present danger". Polish Prime Minister Donald Tusk asserted that "Europe must take up this challenge ... and it must win," tying victory to increased arms spending.

With Trump scaling down U.S. support, European leaders just approved billions to strengthen their own militaries. At a high-stakes summit, 26 out of 27 EU nations backed a plan to boost military funding and reaffirmed support for Ukraine. Hungary refused to sign. Macron says Europe is in a "new era" and must prepare to stand on its own, with or without the U.S.

The EU is launching the ReArm Eu-

rope Plan, an 800 billion euro defense boost to strengthen its military and reduce reliance on U.S. aid. The spending will stay in Europe, fueling massive contracts for top defense companies.

Zelenskyy is now back at the Trump bargaining table and the latest proposed ceasefire between Ukraine and Russia centers on a U.S. proposed 30-day interim ceasefire, following negotiations in Jeddah, Saudi Arabia. The joint U.S.- Ukrainian statement indicates that Ukraine has expressed readiness to accept this immediate ceasefire, which could be extended by mutual agreement, contingent on Russia's concurrent acceptance and implementation.

However, the terms are questionable and subject to Russian reciprocity. Russian response is pivotal, but unlikely. Russian State Duma Deputy Viktor Sobolev has already rejected it, because it would allow Ukraine to rearm and reinstate intelligence sharing between the US and Ukraine.

Social Security Fraud

Almost 20 Million Dead People in Database

Michelle King, the Acting Director of the Social Security Administration (SSA), has resigned after 30 years with the agency. This comes after the Department of Government Efficiency (DOGE) revealed nearly 20 million dead people in the Social Security database, including 2,786 who were listed as over 200 years old. Don't worry, only 18.4 million of them are not actually receiving benefits.

114 year old Naomi Whitehead of Pennsylvania, born on September 26, 1910, is the oldest person currently living in the US. So she's legitimate.

Leland Dudek has replaced King as acting SSA director, and Frank Bisigno has been nominated to head the Department, pending Senate confirmation.

The SSA also announced recently that 7,000 more employees are slated to be fired, and six of its ten regional offices will be closing. Dozens of senior officials, including associate & deputy associate commissioners, have been fired by the Trump Administration.

The SSA Office of the Inspector General and the COVID-19 Fraud Enforcement Task Force were already investigating Paycheck Protection Program loans obtained via 69,000 fabricated Social Security Numbers.

Concerns have been raised over voter registrations linked to fraudulent or unverified SSNs in Arizona, affecting 86,391 votes cast in the 2020 election, and 393,017 voter registrations in 2021. Election fraud investigator Jovan Hutton Pulitzer claims that more than 10,000 Arizona 2020 election voters are linked to the same SSN, but he owns the data and is paying for private data storage until someone is willing to start a legitimate investigation. Pulitzer worked with Cyber Ninjas on the Maricopa County Audit of the 2020 election, and presented initial findings at a televised hearing in July of 2021. You can watch it online.

A whistleblower has recently come forward and claimed that they were incentivized to qualify illegal aliens for long term Social Security Disability benefits,. "They wanted us to try to identify them in such a way that they would qualify for long-term social security disability. Now long-term social security disability is for life. So if they get identified and qualify for long-term social security disability, they are as good as set up for life", in a video recorded interview. "So they instructed us to try to identify, to try to get the client, because once they arrive here, they're now called clients. So they told us that we needed to talk to the client and ask them if they had any headaches, recurring headaches, or any lower back problems, anything that would qualify them for Social Security Long Term Disability", she told the interviewer "Josh", who responded with "But in order to get Social Security disability benefits, don't you need a Social Security number? To which the whistleblower responded "Well, we were instructed in the meeting that one of the first things we were supposed to do was sign them up for Social Security." ActBlue Exposed

Is the Democrat ATM Broken?

The online fund raising platform ActBlue raised \$13.7 billion for Democratic candidates and causes by June 2024. It operates as a political action committee (PAC) but acts as a conduit, meaning contributions are legally made by individuals, but not the PAC itself. Federal law puts limits on donations to candidates and PACS, preventing wealthy donors from pouring millions into candidates' coffers, though they often find ways around that using dark money groups or creating adjacent organizations that do political work without explicitly supporting candidates.

House Oversight Chairman James Comer and House Administration Chairman Bryan Steil, claim that the U.S. Treasury has identified hundreds of suspicious transactions linked to ActBlue, potentially involving money laundering, fraud, or illicit foreign contributions from countries like China, Russia, Iran, and Venezuela.

Social media sleuths have recently suggested that USAID (U.S. Agency for International Development) funds were channeled through Democrat-aligned NGOs to ActBlue, which then distributed them as small-dollar donations to Democratic campaigns. Curiously, donations fell dramatically after USAID funding dried up. However, correlation doesn't necessarily prove causation, as the timing of USAID funding cut aligns with a natural post-election slowdown, and no USAID-NGO funding tied to ActBlue has yet been officially confirmed.

ActBlue's lack of stringent donor verification, such as not requiring credit Card Verification Values (CVV) numbers until August 2024 enables "straw donations," where large sums are broken down into smaller contributions made under unsuspecting donors' names, in a practice known as "smurfing."

Through ActBlue, Arizona US Senator Ruben Gallego received 2,004 individual donations from a random guy in Pennsylvania. Gallego was surprisingly popular with small donors from Massachusetts (\$8 million), including 57 donations from an unemployed woman named "Virginia Smith" during his 2024 campaign.

Investigations by GOP led committees and state attorneys general, have flagged suspicious patterns. A 75-year-old woman reportedly made 6,470 donations totaling \$37,446 between 2022 and 2024, averaging \$5.79 per donation, An 88year-old retired Yale professor reportedly made 7,539 totaling \$213,163, according to FEC records, and he signed an affidavit saying, "I believe this does not reflect my donation frequency or dollars I have donated." A 91-year-old woman appears to have made 2,591 donations totaling \$41,000, according to FEC filings. She also signed an affidavit denying making the reported donations. A 75-yearold woman looks to have made 4,270 small donations adding up to \$32,323. She too signed an affidavit. An Austin Texas resident had more than 10,000 donations totaling \$106,304. A Maryland woman named Lori Ball had a reported 500 donations totaing \$7,000, but insisted she only donated \$5 monthly donations. Mark Block, a Wisconsin Republican strategist filed a lawsuit, stating that his name was used to make a 35 donations totaling nearly \$900 to Kamala Harris' campaign using his name, without his knowledge. Cindy Nowe, a Maryland senior, supposedly donated over 1,000 times to ActBlue in 2022, totaling \$18,849.77, which works out to 3 donations a day every day all year long.

Seven senior ActBlue executives resigned beginning on February 21st of this year, including the customer service director, partnerships director, associate general counsel (the highest-ranking legal officer), an engineer with 16 years at the company, the assistant research director, an HR official, and the chief revenue officer. The pressure of congressional probes, alongside allegations of money laundering and fraud, may have created a hostile work environment or prompted execs to distance themselves from potential legal risks. The lack of transparency about the executives' motives invites speculation: were they fleeing a sinking ship, or were they pushed out to protect the organization from scrutiny? The lawyer, after resigning, posted a now-deleted Slack message warning colleagues, "We have Whistleblower Policies for a reason," before losing his access to internal systems.

The allegations against ActBlue highlight real vulnerabilities in its donor verification processes, potentially enabling fraud or exploitation. The thousands of small contributions from unlikely donors warrant investigation, as they could indicate either systemic reporting errors or deliberate money laundering.

As Democrats gear up for the 2026 elections the potential fall out could give Republicans an edge on fund raising using their similar WinRed online platform.

AG Conspired in Secret Pact

Mayes Caught in Conspiracy

Arizona Attorney General Kris Mayes has thrust herself into the national spotlight for joining a clandestine coalition of 22 liberal attorneys general bent on resisting President Donald Trump's agenda. Documents recently unearthed by the Heritage Foundation's Oversight Project reveal a secretive agreement, signed just days after Trump's landslide reelection in November 2024, aimed at thwarting his efforts to end birthright citizenship, a policy many hail as a long-overdue correction to America's broken immigration system.

The agreement, dated November 8, 2024, binds Mayes and her counterparts in a coordinated legal offensive against Trump's immigration reforms. This isn't just a policy disagreement, it's a calculated rebellion against a duly elected president, cloaked in the guise of defending the Constitution. The compact pledges collaborative efforts to craft lawsuits, draft amicus briefs, and shield their strategies from public scrutiny, all while claiming to protect the 14th Amendment's guarantee of birthright citizenship.

The secrecy of the pact is particularly unsettling. The agreement forbids thirdparty access to shared information, including pre-suit strategies and communications, and even requires a five-day heads-up among the AGs before responding to public records requests.

Trump's executive order, issued on his first day back in office, seeks to end automatic citizenship for children born to illegal immigrants. For decades, conservatives have argued that the 14th Amendment was never intended to grant citizenship to those who break our laws to enter the country. Yet Mayes and her secret pact allies, have already joined lawsuits that have temporarily blocked the order, with federal judges in four states siding with their claims.

Mayes' track record only fuels the outrage. She has already targeted Trump allies, indicting 18 individuals, including Rudy Giuliani and Mark Meadows, in the so-called "fake electors" case tied to the 2020 election. Trump himself was named an unindicted co-conspirator, a move seen as political persecution.

Mayes joined a coalition of 23 state attorneys general in a lawsuit against the Trump administration to block a policy from the Office of Management and Budget (OMB) that ordered an indefinite freeze on trillions of dollars in federal funding. On January 28, a federal judge in Rhode Island issued a temporary restraining order, followed by a preliminary injunction on February 9, 2025, ordering the restoration of frozen funds.

Mayes was part of a coalition of 22 attorneys general that secured a nationwide preliminary injunction against a Trump administration plan to cap indirect payments from the National Institutes of Health to universities at 15%. A federal judge in Massachusetts halted the cuts.

Mayes was a lead plaintiff among 14 state attorneys general in a February 2025 lawsuit arguing that Elon Musk's leadership of Trump's Department of Government Efficiency (DOGE) violated the Constitution.

Prior to that, she joined 19 attorneys general in a suit blocking DOGE's access to the U.S. Treasury Department's payment system. A federal judge ruled DOGE lacked legal authority, a decision upheld in early February as the coalition sought a preliminary injunction.

On January 27, 2025, Mayes joined a coalition suing multiple federal agencies for illegally terminating probationary federal employees en masse, a move tied to Trump's personnel policies.

With this secret compact, she's doubling down, positioning herself as the tip of the spear in a nationwide resistance against Trump's America First agenda.

Mayes, a Democrat who won her seat in 2022 by a razor-thin 280 votes, was once a Republican, she switched parties in 2019, citing "Trumpism" as her excuse. Now, she's proving her critics right by aligning with the radical left to defy the President whom Arizona voters chose by a clear margin. Her office's spokesperson, Richie Taylor, insists Arizonans didn't vote for "chaos and shredding the Constitution," but Arizonans didn't vote for an AG who'd conspire behind closed doors to subvert their choice at the ballot box either. For a state like Arizona, grappling with the real-world consequences of illegal immigration, with overrun border towns, strained public resources, and a fentanyl crisis fueled by cartels, Mayes' priorities seem dangerously misplaced.

VA to Redirect Funds

Benefits Will Not be Cut

On February 24th, the Veterans Administration announced the elimination of over 1,400 probationary employees in "non-mission critical positions", following a cut of more than 1,000 workers earlier in the month. These employees, primarily bargaining-unit staff with less than one year in competitive service or two years in excepted service, were targeted to save over \$83 million annually in the latest round alone, with total savings from both cuts exceeding \$98 million per year.

VA Secretary Doug Collins has stated that these funds will be redirected toward "health care, benefits, and services" for veterans, emphasizing a focus on frontline support over administrative overhead. Collins has firmly denied any plans to reduce veterans' benefits, asserting in a February 13, 2025, video that "Veterans benefits aren't getting cut."

The Department of Government Efficiency (DOGE) has also highlighted over \$500 billion in annual federal expenditures on programs with expired congressional authorizations, including roughly \$120 billion tied to the VA's medical services under the Veterans' Health Care Eligibility Reform Act of 1996, which lapsed in 1998 but continues to receive appropriations.

Biden Autopen Controversy Who Really Signed the Documents?

Former President Joe Biden relied heavily on the use of an autopen, a machine that mechanically replicates a signature, to sign official documents during his presidency. This raises serious questions about his awareness, mental capacity, and the legitimacy of his administration's actions.

The controversy emerged this month, when the Heritage Foundation's Oversight Project claimed that nearly all documents bearing Biden's signature from his four-year term used an identical autopen signature. An exception which featured a different signature, was his July 2024 letter announcing his withdrawal from the 2024 presidential race, they noted. This discrepancy has fueled speculation about who truly controlled the White House during Biden's tenure, with numerous critics now suggesting that unelected staff may have wielded undue influence.

The Oversight Project's investigation asserted that it reviewed "every document we could find with Biden's signature" and found consistent use of the autopen on executive orders, pardons, and other official directives. These signatures, typically a straight line followed by "R. Biden Jr.," appeared identical across documents, contrasting with the "J.R. Biden" signature on his withdrawal letter. The group argued that this pattern suggested Biden may not have personally signed or even approved many key decisions.

Missouri Attorney General Andrew Bailey, seized on the findings to demand a Department of Justice investigation. Bailey argued that if Biden's mental decline allowed un-elected aides to enact policies without his knowledge, those actions, including executive orders and pardons, could be unconstitutional and "legally void." He pointed to anecdotes like House Speaker Mike Johnson's claim that Biden didn't recall signing a 2024 order pausing liquefied natural gas exports, suggesting a broader pattern of detachment.

This could spark countless legal battles over Biden's entire presidency, though no court has definitively ruled on the constitutionality of autopen signatures. George W. Bush sought but didn't use a DOJ opinion approving it..

The autopen itself isn't new, presidents such as Harry Truman, Barack Obama, and Donald Trump have used it for convenience, especially for mass correspondence or when physically absent. However, the scale of Biden's alleged reliance has sparked unique concern, particularly given persistent questions about his cognitive health.

During his tenure in office, Biden faced scrutiny over gaffes, public stumbles, and moments of apparent confusion, such as needing guidance from world leaders at public events. His shaky debate performance in 2024 and subsequent exit from the race only amplified concerns. The optics of not physically signing countless documents only further tarnishes Biden's legacy, painting him as an easily manipulated mentally diminished figurehead.

Measles Misinformation?


Actual Risks and Comparative Fatalities

There has been a lot of recent hype surrounding a measles outbreak in TX, that's being blamed on a German speaking Mennonite community that doesn't follow the recommended vaccination protocol.



Dying 'with' a virus and dying 'from' a virus is a huge distinction. In the past 25 years, very few deaths have been attributed to measles in the US, and even those cases lack confirmation that measles was the primary cause, let alone whether the strain was vaccine-derived or wild-type. Conversely, the Vaccine Adverse Event Reporting System (VAERS) has recorded hundreds of deaths following MMR vaccination. Estimates suggest that only 1% of actual cases are reported.

In our effort to eradicate a benign, childhood illness that once conferred lasting immunity, "experts" have instead created an epidemic of vaccine-induced harm. The hysteria over measles is not only misguided it is a calculated distraction from the devastating consequences of mass vaccination.

In 19th Century America tens of thousands died with, or of, measles annually. By 1960, and before the vaccine's introduction, improvements in sanitation and nutrition had eliminated 98% of measles fatalities. Good nutrition remains a best defense against most chronic and infectious illnesses. Vitamins A, C, and D, and foods rich in vitamins B12, C, and E should be part of a balanced diet.

Toxic Girl Scout Cookie Warning

A Wake-Up Call for the Health Conscious

For generations, Girl Scout Cookies have symbolized nostalgia, community, and the entrepreneurial spirit of America's youth. But before you take another bite, a shocking revelation has cast a shadow over this beloved tradition: these cookies contain toxic ingredients.

Recent lab tests, commissioned by consumer advocacy groups like Moms Across America and GMOScience, uncovered alarming levels of glyphosate and heavy metals in every single Girl Scout Cookie sample examined. Glyphosate, the active ingredient in Roundup weedkiller, was found in 100% of the 25 samples tested across California, Iowa, and Louisiana. Levels ranged from 13.57 parts per billion (ppb) in Peanut Butter Patties to a staggering 111.07 ppb in Thin Mints—reportedly 334 times higher than what experts deem safe. Alongside glyphosate, 88% of samples contained all five tested toxic metals: aluminum, arsenic, cadmium, lead, and mercury. Peanut Butter Patties topped the list with lead at 42.5 ppb and aluminum at 27,500 ppb, while 76% of samples exceeded EPA safety thresholds for cadmium in drinking water.


More than a cookie scandal, it's a symptom of a diseased food supply chain. Glyphosate, a known endocrine disruptor, has been linked to cancer, autism, reproductive damage, and gut health issues. Heavy metals like lead, for which the FDA admits there is no safe exposure level, threaten brain development, particularly in children—the very demographic these cookies target. Cadmium and arsenic, meanwhile, are tied to cancer and neurological disorders. That these toxins infiltrate a product marketed by and for young girls, under the banner of "building character," is a betrayal of American values.

The Girl Scouts' response has been tepid at best, claiming their cookies meet FDA safety standards and that trace contaminants are unavoidable in plant-based foods. But the FDA's lax thresholds, allowing glyphosate residues up to 5,000 ppb in some grains, should not be a shield but rather a spotlight on regulatory failure. If medical marijuana must pass rigorous purity tests, why should a child's cookie be exempt? An \$800 million cookie empire profiting from peddling poison exposes a double standard in our food safety framework.

This isn't just about Girl Scout Cookies, it's about a food industry hooked on cheap, chemically laden ingredients. Non-organic peanuts, wheat, and GMO crops like corn and soy, staples in these recipes, are drenched in glyphosate as a pre-harvest desiccant. Heavy metals seep in from polluted soil and water, a legacy of industrial negligence. The result? A nation where over 63% of children suffer chronic diseases tied to environmental toxicants, according to Moms Across America.

The Girl Scouts should reformulate their cookies with clean, organic ingredients, use coconut oil instead of chemically processed seed oils, unsprayed wheat instead of glyphosate-soaked grains. As a consumer, wouldn't you prefer that?

Girl Scout Cookies, once a symbol of innocence, now epitomize a broader crisis. Let's make them a catalyst for change by demanding purity, protecting children, and making cookies healthy again. Ditch nostalgia, healthy kids and a food system that doesn't trade profit for poison is a future worth fighting for.

The DOGE Report

The Department of Government Efficiency (DOGE), led by Elon Musk, has been making waves in the federal government since its inception. Here are some of the key accomplishments so far:

Spending Cuts: DOGE has claimed more than \$1 billion per day in spending cuts, focusing on canceling diversity, equity, and inclusion (DEI) programs, consulting contracts, and underutilized leases.

Efficiency Improvements: DOGE has been working to modernize federal technology and software to maximize efficiency and productivity.

Contract Cancellations: The department has canceled numerous federal contracts, resulting in significant savings. For example, they canceled 36 contracts across six agencies, leading to savings of about \$165 million.

These efforts have been met with both praise and criticism, as DOGE continues to push for greater efficiency and accountability within the federal government.

Career bureaucrats held more power than our elected officials, until DOGE came along. Some highlights from the last month include:

Pilot program across 14 civilian agencies to audit unused/unneeded personal credit cards, "P-cards", (~700K accounts with ~\$30B spent in FY24). After 8 days, ~24,000 cards were de-activated, which will likely double. "There are still almost twice as many credit/purchasing cards as people in the government, and the limits are \$10,000!" - Elon Musk

NIH canceled grants for ~\$10.9 million including: -\$1.7M for the "China Health and Retirement Longitudinal study" at Peking University in Beijing, China -\$135K for a research grant to China Medical University in Shenyang, China -\$142K for "using telehealth to improve access to gender-affirming care" -\$1.3M for "transforming health for gender-diverse young adults" -\$120K for "personalized 3-D avatar tool development" focused on "gender identities" -\$400K for researching "sources of minority stress and alcohol consumption" among "adults who report uncertainty about their sexual orientation" -\$160K for researching "racialized sexual discrimination" among "young sexual minority men of color" -\$241K for "an intervention to promote healthy relationships among transgender and gender expansive youth"

US taxpayer dollars were going to be spent on the following, all which have been cancelled: \$60M for "Indigenous Peoples and Afro-Colombian empowerment" - \$74M for "inclusive justice" in Colombia - \$79M for "primary literacy" in Kenya - \$37M for "female empowerment" in Colombia - \$8M to "Reduce stigma, discrimination, and violence against LGBTQI+ communities" in Lesotho - \$3.3M for "being LGBTQI in the Caribbean" - \$25k to increase "Vegan Local Climate Action Innovation" in Zambia- -\$69mm for the Eurasia Foundation to do "digital transformation activity" in Europe -\$32mm to Internews for programs including "media enabling democracy, inclusion, and accountability in Moldova" and the promotion of "sustainable media outlets" -\$7mm for the American Bar Association to promote the "resilience" of the "Eurasian legal sector and civic society" -\$520mm for a consultant to do ESG investments in Africa and "mobilize private sector resources and expertise" -\$25mm to "promote biodiversity conservation and promote licit livelihoods" by developing "socially responsible" behaviors in Colombia -\$40mm to "improve the social and economic inclusion of sedentary migrants" -\$42mm for Johns Hopkins to research and drive "social and behavior change" in Uganda -\$45mm to "address the needs, opportunities, and challenges identified by activists and other civic actors engaged in nonviolent collective action" -\$52mm for the World Economic Forum-\$14M for cash vouchers for illegal migrants \$55K for a climate change presentation by female & LGBT journalists in Argentina-\$3M for "Being LGBTQ in the Caribbean"-\$7M for Black, Indigenous, People of Color (BIPOC) speaker series IN Canada-\$16K for "united and equal queer-feminist discourse" IN Albania-\$87.9M for "drip irrigation system" for Taliban farmers in Afghanistan.

Animal Rights is not Animal Welfare

We have no problem with the extiction of domestic animals." - Wayne Pacelle, the former president and CEO of the Humane Society of the United States, former chairman Animal Rights Network Inc

As a lifelong animal lover, rescuer, and animal welfare advocate, I have spent decades educating the public about why so-called "animal rights" is a subversive term and a dangerous idea that is wholly incompatible with the responsible care and stewardship of our animal friends. The terms "animal rights" and "animal welfare" are not interchangeable, they are actually polar opposites.

The confusion is both understandable and intentional. The linguistic propaganda is intended to deceive. The psychological operation uses heart wrenching ads and warm fuzzy terms such as compassion, respect, humane, ethical, kindness, and protection, convincing well meaning animal lovers to donate money to slick organizations with well paid board members whose core mission is to lobby for laws that work against the interests of actual animal welfare.

Organizations such as HumaneWatch.org, the National Animal Interest Alliance, and the recently defunct Protect the Harvest, have fought the good fight for years to educate the public, oppose bad laws, and protect the rights of animal owners.

Some animal rights groups such as "Animal Liberation Front" (ALF), a group that began in the UK as the Hunt Saboteurs, are actually considered to be domestic terrorist groups by the FBI. People for the ethical Treatment of Animals, PeTA, was created as a fundraising front for ALF. Not capitalizing the "e" for "ethical" is basically a sick inside joke. The animal rights movement in America gained momentum in the 1980's, but began in the 70's in the United Kingdom, and was thrust into the public dialog by Australian philosoper Peter Singer and his book "Animal Liberation.

In 2007, radical animal rights lobbyist Julie Lewin published a 276 page spiral bound how to political strategy guide called "Get Political for Animals and Win the Laws They Need". I obtained a copy at the time, and it was quite enlightening. A tactic called "ratcheting up" is used to erode animal owners rights. Get a soft law on the books, then incrementally increase it so the normies don't object.

The ultimate goal of animal rights advocates is enjoyment of animals only at a distance without human intervention, with vast tracts of land set aside for nature and humans crammed into easily controlled "15 minute cities" living in pods and eating bugs. Meanwhile, the Mohave Valley Irrigation and Drainage District (MVIDD) continues to operate with a troubling lack of transparency.

Tourists from around the world enjoy historic Oatman, blissfully unaware that the Town is only still there because a propane tank pressure relief valve didn't fail. At 9:52 pm on February 27th, a fire was reported at the Olive Oatman Restaurant & Saloon. Although the official cause is unknown, a local source told the Mohave Free Press that a suspected electrical fire started in the back of the unoccupied building causing a large half full propane tank to get so hot that the PRV started releasing propane to relieve pressure. This caused propane fueled flames to shoot skyward and the resulting inferno destroyed all but the front facade of the building, which survived only due to the thickness of the walls. The General Store only feet away also sustained fire damage. But it could have been so much worse.

The PRV controlled propane release was critical because a tank pressure failure could cause a BLEVE (Boiling Liquid Expanding Vapor Explosion), a devastating event where the tank bursts, releasing a fireball and shrapnel.

Oatman has no fire hydrants, so the Oatman Fire Department quickly set up what were essentially two large swimming pools with a fire truck in the middle pumping water from the pools onto the blaze, which were filled in rotation by water trucks dumping and refilling from both directions. More than 10 agencies sent trucks and firefighters from as far away as San Bernadino and Lake Havasu City.

Oatman only has two water trucks, with one out of service due to a bad solenoid, our source explained, and Oatman doesn't have enough water to put out a fire.

She was confronted with a community she felt was indifferent and uncooperative to her needs.

Ms. Gilbertson later came to realize that her struggles were not isolated events. She met other families facing similar situations in requesting help for their children who had behavior health challenges. Ms. Gilbertson took on the responsibility of uniting these families and worked together with them to build a better mental health system for their children. Through the efforts of Ms. Gilbertson, families had their very first support group on March 11, 1987. This led to the formation of M.I.K.I.D. The organization focused on supporting families, and advocating at the State legislature and State Agencies for improving the children's behavioral health system.

M.I.K.I.D.'s mission is to improve the behavioral health and wellness of children and youth through a family-centered approach. They employ professionally trained staff and offer an array of services to families of children with emotional and behavioral challenges. M.I.K.I.D. provides education, resources, and support. Their programs focus on developing skills, networks, and readiness through M.I.K.I.D. staff providing one-on-one family support, transitional age youth services, peer support, health promotion, support groups, training, and education, both individual and community-based living skills, respite, and connecting families and individuals with natural supports in the community. Their services include youth 0-25 years old who have mental health issues. M.I.K.I.D. services are unique in that the staff providing many of these services are family members, parents, and young adults who have personal lived experience in dealing with behavioral health needs. They require all staff who provide services to the parents we serve to have lived experience. M.I.K.I.D. focuses on supporting and educating youth and families with developing coping skills.

Davis Camp Park



Nestled along the Colorado River, Davis Camp is a hidden gem that offers a compelling mix of natural beauty, historical significance, and recreational opportunities. Located along nearly two miles of developed shoreline just below Davis Dam and north of the Laughlin Bridge in Bullhead City, Davis Camp has evolved from a utilitarian worker's village into a vibrant recreational haven that attracts over 200,000 visitors annually.

The river's clear, cool watersm maintained year-round due to the dam's influence, create an ideal setting for water-based activities. Whether you're an adrenaline junkie or a relaxation seeker, the park caters to both. Some original 1946 homes have been renovated into vacation rentals, allowing you to stay in a piece of history while enjoying modern comforts. The park's ranger station, a relocated 1960s home, and the 2010 amphitheater at South Beach reflect its ongoing evolution, blending the old with the new in a way that feels authentic rather than commercialized.

Davis Camp also stands out for its affordability and variety of lodging options, catering to different types of travelers. Day-use fees are reasonable at \$10 per vehicle, while dry camping starts at \$30 per night. For a more immersive experience, you can opt for RV sites with full hookups (up to 50 feet in length) at \$35 daily, or rent a vacation home—two-bedroom units start at \$80 per day in the off-season. Summer weekend passes (\$40 per person, including camping) and holiday weekend options make it budget-friendly for families or groups, especially during peak times like Memorial Day or the Fourth of July. Maintained by Mohave County, the park's self-sustaining model, funded through user fees since 1991, ensures that revenue collected directly supports maintenance and new developments, which is a refreshing contrast to profit-driven tourist traps.

County Board Report

The Board of Supervisors authorized County staff to place the old Mohave County Animal Shelter up for public auction. Located at 950 Buchanan Street in Kingman, the facility was vacated by the County in May of 2024 and the Animal Shelter was moved to 3423 N. Burbank. The property has been appraised at \$387,000 and the auction will be held on April 21st, 2025.

District 4 Supervisor Don Martin proposed placing stanchions and ropes around the Supervisor's dais during Board meetings for security. District 5 Supervisor Ron Gould requested if the item were to be approved, that there be an opening in front of his seat so that his constituents could approach and speak with him. After a comical debate where Martin tried to goad Gould into admitting he carries a firearm, Martin was unable to get another supervisor to second his motion, and no action was taken. Martin later went on a social media posting spree to deride Gould for exercizing his 2nd Amendment right to bear arms.

Two items were brought back from the February 3rd meeting. The request for a waiver of \$3,600 in fees for the Home and Garden Show by Desert Canyon Events, LLC was denied. The Board did approve a \$3,210 grant from Best Friends Animal Society for the Animal Shelter Director to attend training, despite Best Friends being a religious cult. Supervisor Gould was the lone dissenting vote.

A Kingman area housing development project request for rezone brought back for reconsideration from December 2nd by District 1 Supervisor Travis Lingenfelter was sent back to the Planning and Zoning Commission because the Commission failed to ask the developer questions during their meeting.

Chief Financial Officer Luke Mournian gave a presentation regarding Zero-Based Budgeting (ZBB). Former Supervisors Buster Johnson and Hildy Angius each had tried since at least 2015 to implement ZBB to no avail, and now Gould is trying. At the March 3rd meeting, Gould agendized an item to instruct the Development Services Department to begin implementing a ZBB for fiscal year 2026. After much push back from Mournian and County Manager Sam Elters, the Board rejected financial transparency and accountability two to three, with only District 2 Supervisor Rich Lettman voting with Gould. Supervisor Gould pointed out that the People are very much in favor of DOGE, the federal Department of Government Efficiency implemented by President Donald Trump.

Also at the March 3rd meeting, the BoS' Rules of Order were updated. There is no longer a dress code, although it was pointed out that the meetings are broadcast via the County Television District and the FCC rules do restrict some content that could be displayed on clothing. The People continued to object to moving the Call to the Public to the end of the meetings, but that issue fell on deaf ears, again.

Supervisor Lingenfelter brought forward an item regarding the implementation of biannual reporting on the progress of the Mohave County 2023-2028 Comprehensive Economic Development Strategy. The Board voted to replace restaurants and hospitality with data centers in targeted industry sectors.

The Board voted four to one with Martin dissenting, to split the opioid settlement money equally amongst the five districts, similar to the American Rescue Plan Act (ARPA) funds. County Manager Elters complained that it strained staff's capabilities when working to implement the many requests of the Supervisors for the ARPA projects. Supervisor Borrelli asked for some parmesan on the word salad given by Elters. Lingenfelter told whiny Elters "I think you're overcomplicating it".

Golden Valley Matters

A group of nearly 200 Golden Valley residents packed the Fire Training Station on February 25th to voice concerns about a proposed 29 acre development on Hwy 68 and S. Teddy Roosevelt. The meeting between locals and Las Vegas developer Peter Cimino was facilitated by community activist Danielle Ohle-Keck. District 4 Supervisor Don Martin and District 2 Supervisor Rich Lettman were also in attendance.

Cimino made his pitch to locals about a proposed rezone and amendment to the General Plan that would allow him and his Canadian business partners to build a grocery store with fast food restaurants, gas station with convenience store, apartments, storage facilities, and houses, directly to the East of Shipps Estates. The proposal had received unanimous support from the Planning and Zoning Committee.

Not one person at the community meeting voiced support for the project, citing concerns about lack of infrastructure, public safety, traffic and road maintenance, and the issues surrounding water use and wastewater treatment.

Cimino admitted under questioning that no actual grocery store or fast food chain had committed to the project, and some locals feared that if the proposal went forward all that might manifest would be more unwanted high density housing with no additional jobs.

About two dozen Golden Valley locals made their voices heard at the subsequent Public Hearing on the project during the Board of Supervisors meeting on March 3rd, where Cimino offerred to withdraw plans for the 47 unit apartment complex portion of the project.

During public comment it was revealed to the supervisors that Cimino, the previous owner of Castle Rock restaurant and event center, had been a debtor in bankruptcy where he was found guilty at trial of inducing an elderly man to transfer \$80,000 worth of property under false pretenses.

Ultimately, the Board unanimously rejected the rezone and General Plan Amendment over concerns that Cimino had not done adequate research and preparation. Cimino admitted to Supervisor Borrelli that he hadn't even reached out to ADEQ regarding wastewater compliance requirements.

The Arizona Attorney General's Office is warning consumers about expired and potentially dangerous compounded prescription medications sold to the public by Slimming Grace, located at 1115 Stockton Hill Road, Suite 101, in Kingman.

Compounded medications are customized pharmaceutical preparations created by a licensed pharmacist to meets the specific dosage and formulation needs of individual patients.

Compounded prescription medications and other products were sold to the public despite being expired. Expired compounded medications may become unstable, lack necessary preservatives, and pose an increased risk of contamination, making them unsafe for use. Some of these medications were also identified as potentially dangerous for pregnant women and their unborn children.

Additionally, according to the official press release, some medications were dispensed without the required medical consultation or valid prescription. Compounded medications should only be provided after a proper medical evaluation by a licensed physician, a valid prescription, and pharmacist or physician counseling. Many require follow-up care to ensure effectiveness and detect possible complications, such as toxicity, allergic reactions, or other harmful side effects.

The public warning suggests an initial step to protect public health rather than a legal enforcement action, but it raises questions about the scope and current status of the investigation leading up to the press release, as well as the Attorney General's plans related to the popular weight loss clinic.

Anyone who has purchased or used medications or products from Slimming Grace in Kingman, AZ should immediately consult a qualified medical provider to assess potential health risks.

Consumers who purchased or received these products are urged to contact the Arizona Attorney General's Office at 602-542-7977 to arrange for proper disposal.





How to survive in a modern world

"Compost everything!" Well almost everything. Now that the weather is warming, it's the perfect time to start.

Composting involves the decomposition of organic matter by microorganisms, fungi, and other de-composers. This process occurs in a controlled environment where conditions such as moisture, temperature, and aeration are managed to facilitate the breakdown of materials. The end product is a dark, crumbly soil amendment that is rich in nutrients and beneficial microorganisms.

Compost improves soil structure, aeration, and moisture retention. It adds essential nutrients like nitrogen, phosphorus, and potassium, which are vital for plant growth. Healthy soil supports robust plants that are more resistant to pests and diseases. Compost can also introduce beneficial microorganisms that help suppress soil-borne pathogens.

By creating your own compost, you reduce the need to buy commercial chemical fertilizers and soil amendments, saving money in the long run.

There are several methods of composting, including: using a compost bin or tumbler to contain materials, creating a compost pile in a designated area of your yard, or using worms to break down organic matter, ideal for small spaces.

Compostable materials can be categorized into two groups:

Green Materials: Nitrogen-rich items such as fruit and vegetable scraps, coffee grounds, grass clippings, and green leaves.

Brown Materials: Carbon-rich items like dried leaves, straw, cardboard, and paper.

Start your compost pile or bin by layering green and brown materials. A good rule of thumb is to maintain a ratio of about 2:1 (browns to greens). This balance helps create the right conditions for decomposition. Then pee on it. Not joking, urine helps to kickstart the process.

Turn your compost regularly (every few weeks) to aerate it. This introduces oxygen, which is essential for the microorganisms that break down the materials. Keep the compost moist but not soggy. If it's too dry, decomposition will slow down; if it's too wet, it may become anaerobic and smell bad.

Composting takes time. Depending on the materials and conditions, it can take anywhere from a few weeks to several months for compost to be ready. You'll know it's done when it's dark, crumbly, and has an earthy smell.

Once your compost is ready, you can use it in various ways:

Soil Amendment: Mix compost into garden beds to improve soil quality.

Mulch: Spread a layer of compost around plants to suppress weeds and retain moisture.

Fertilizer: Use compost as a top dressing for potted plants or as a nutrient boost for vegetables and flowers.

In conclusion, by turning organic waste into valuable compost, you can create a thriving garden ecosystem that benefits both your plants and the planet.



CHICKEN AND BISCUITS


- 1 (16 oz) can cream of chicken soup


